VBM is not a Silver Bullet

NO ONE SHOULD HAVE TO CHOOSE BETWEEN THEIR HEALTH OR HAVING SAY IN OUR DEMOCRACY. Safe, accessible in-person voting locations are needed to support voters that:

- don't trust voting by mail
- need a replacement ballot for any reason,
- need in-person language or physical assistance,
- do not have an address to receive a vote-bymail ballot,
- never hear or learn about the shifts to a new, all vote-by-mail model,
- are new to voting and need in-person assistance, and
- want to register and vote on the same-day.

Convergence of Factors for the November Election



- Presidential Election = higher voter turnout, esp. of new and infrequent voters
- COVID-19 Pandemic has disproportionate impact on lowincome communities of color
- Government Distrust at an alltime high
- Historic Disenfranchisement

Historic Disenfranchisement

- 13th Amendment (1864)
- Jim Crow (1865-1965)
- Vagrancy Act (1855)
- Bisbee Deportation (1917)
- Operation Wetback (1950s)



8 of the 12 states with the largest Hispanic population growth between 2000 and 2010 passed laws making it harder to vote. **7** of the **11** states with the highest African American turnout in 2008 have new voting restrictions in place.

- Purging of voter rolls (2020)
- Misinformation (2020)
- Long lines (2020)
- Elimination of early voting (2020)
- Voter intimidation
- Voting Rights Act overturning (2013)
- Mass Incarceration

Societal Dynamics fueling Government Distrust

- Division: political, racial, socioeconomic
- Increasing White Supremacy
- Policies targeting specific communities
- Gerrymandering

- Early education on and conversion to VBM

- Partnerships between election officials and CBOs re: placement of voting locations
- Trusted messenger strategies to ensure infrequent voters know about the upcoming changes and their options to cast a ballot
